**ORDER**

Van Buren County, Michigan, this 20<sup>th</sup>

CIRCUIT JUDGE

This matter having come before the court upon the agreement of the attorneys for the parties; and the agreement having been entered on the record with the approval of the court; and the court being fully advised in the premises;

IT IS HEREBY ORDERED AS FOLLOWS:

1. The control device anticipated under the PETITION FOR LOCATING, ESTABLISHING AND CONSTRUCTING AN INTERCOUNTY DRAIN OR

DRAINS, dated September 28, 1994, involving the Cedar Lake Intercounty Drain, will be at a level of 4.1 feet above the invert of the culvert at M-40. Based on the elevations contained in the drawings of Wightman, Peirce, Inc., dated August 26, 1994, the parties believe the elevation of the device would be 893.4 feet of elevation, and the Court sets the lake level at that elevation.

2. All other matters relating to the above-mentioned Petition shall continue to be governed by the Drain Code of 1956.
3. The device anticipated and to be constructed under the above-mentioned Petition will not be subsequently altered, changed or modified without further order of this Court.
4. Petitioners'/Appellants' Petition for Review is dismissed with prejudice.


