WHEREAS, Bloomingdale Township Ordinance #115 (2-96) provides that the Township Board shall, by Resolution, set the charges for permits, for burial spaces and other charges associated with the operation of the cemetery; and

WHEREAS, the imposition of a charge or fee for burial in the Bloomingdale Township Cemetery directly relates to the cost of benefits received.

NOW, THEREFORE, BE IT HEREBY RESOLVED:

The following charges and fees shall be set and collected in connection with the Bloomingdale Township Cemeteries:

1.	Resident burial space:	\$50.00
2.	Non-resident Burial space:	\$1000.00
3.	Grave Openings: Weekdays- Resident	\$600.00

4.	Grave Openings: Saturdays-Resident	\$900.00
	Non-Resident	\$1000.00
5.	Grave Openings: Sundays & Holidays Resident	\$1500.00
	Non-Resident	\$1600.00
6.	Cremation: Weekdays–Resident per urn	\$250.00
	Non-Resident	\$350.00
7.	Cremation: Saturday –Resident per urn	\$350.00
	Non-Resident	\$450.00
8.	Cremation: Sunday and Holidays Resident per urn	\$1500.00
	Non-Resident	\$1600.00

9.	Cremation: Weekdays –Infant resident per urn	\$150.00
	Non-Resident	\$175.00
10.	Cremation: Saturday –Infant resident per urn	\$350.00
	Non-Resident	\$450.00
11.	Cremation: Sunday & Holidays Infant Resident	\$1500.00
	Non-Resident	\$1600.00

Foundations: .45 per square inch with a 4 inch border required,
