- Fire Board- Chief Derek Babcock reported that there were 39 calls for the month with 13 being in Bangor Township. Also it has been the first time in a long time that Bangor Township and Arlington township both had the same number of calls and the City of Bangor had fewer at 11 calls. The Department is fully staffed with 22 active members. They have 3 that are finishing up medical first responder classes and 2 that are waiting for the next set of classes to begin. The Department had an Ice Rescue training and it went very well and they are hoping to be leaders of an Ice Reduce next year for Michigan. The Fire Board has approved their new budget for the year and has set a meeting date of March 26, 2025 at 6pm for all the municipalities.
